Central America Renewable Energy Forum: II March 1, 2011 – 8:45am to 1:00pm

The Central America Renewable Energy Forum (CAREF) is designed to encourage dialogue among senior Central American and Dominican Republic energy officials, current and potential private sector investors and regional stakeholders. The objective of the dialogue is to identify and discuss how to address obstacles to increased use of renewable energy in Central America. CAREF was initiated by the Department of State in November 2010, consistent with the Energy and Climate Partnership of the Americas (ECPA), and the first roundtable was held in Atlanta in November of 2010. Participants included the Ministers of Energy from Nicaragua and Panama, Vice Ministers from El Salvador and Costa Rica, and senior officials from Guatemala, along with NGOs, and private investors from the U.S. and the region.

CAREF II will highlight financial programs regional partner countries and investors can take advantage of to encourage U.S. exports of renewable energy technologies as well as efforts in the region to unify the electric grid and broaden renewable energy development. Assistant Secretary of State for Western Hemisphere Affairs Arturo Valenzuela will open the event, hosted by Assistant Secretary of State for Economic, Energy and Business Affairs Jose W. Fernandez. The half-day session at the State Department in Washington, DC will be kicked off by senior representatives of the Export-Import Bank of the United States (EXIM), the Overseas Private Investment Corporation (OPIC), the United States Trade and Development Agency (USTDA), the Inter-American Development Bank (IDB), and the private sector, through the Council of the Americas and the American Council on Renewable Energy (ACORE) and its Latin American and Caribbean Council on Renewable Energy.

The **CAREF** program seeks to support a multi-party dialogue between the private sector, civil society and Central American governments. Invitations have been accepted by delegates from Guatemala, Honduras, Dominican Republic, Nicaragua, El Salvador, Costa Rica. IDB, World Bank, and OAS staff will also attend. In addition, representatives from Mexico and Brazil are confirmed, underscoring a broad hemispheric interest in promoting clean energy in the Central American region. Overarching goals are to encourage growth in renewable energy and to deepen regional business partnerships.
