Steering Comittee

At the Second Ministerial Meeting of ECPA held in Merida, Mexico, in May 2015, the participating countries stressed the need to boost operational aspects of the Partnership. To that end, they established a Steering Committee which **guides ECPA's activities and seeks to represent the interests and particularities of each sub-region in the Americas**.

Through this governing body, the participating countries lead the Partnership to ensure its effectiveness, propose actions that support the priorities identified in the Action Plan, and identify technical and financial resources to undertake them.

The Steering Committee comprises 10 countries and is chaired by the Dominican Republic, as the host of the 2024 ministerial meeting.





In addition to the Steering Committee, all major **ECPA initiatives are conducted in consultation with the National Focal Points** of the countries that are active members with democratically-elected governments of the Organization of American States (OAS).

Techincal Assistance & High-Level Diaologues

Based on the assessment of the needs and priorities of the member states and the ongoing consultations with our Steering Committee, the Technical Coordination Unit conducts technical assistance activities aimed at strengthening the capacities of the region's energy sector.

ECPA is the only hemispheric platform for energy dialogue and cooperation gathering all OAS Member States and engaging governments and companies in the promotion of energy sustainability.
